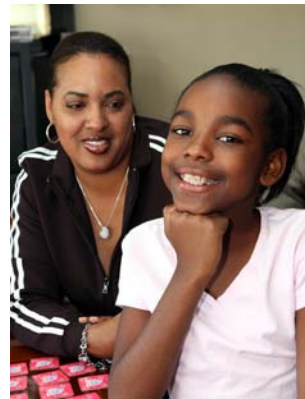

CASA Programs in Louisiana Among Nation's Best

Louisiana ranks among the best in providing advocacy for abused and neglected children in foster care through its Court Appointed Special Advocate (CASA) programs, according to the National CASA Association. CASA volunteers are unique in that they focus exclusively upon the child's best interest. CASA volunteers are recruited from the community and are most often selected to serve only one child.

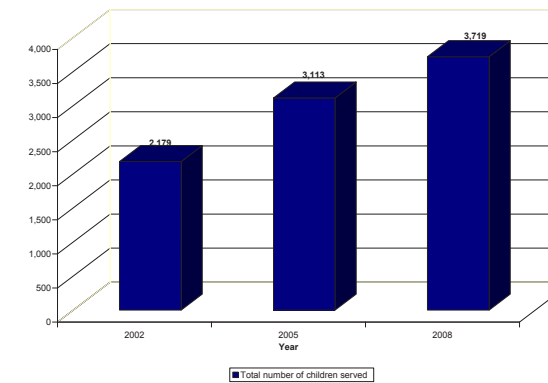
For Louisiana, CASA programs are serving more children with more volunteers than typical CASA programs in other states. Nationally, a CASA program has 37 volunteers serving 118 children. CASA programs in Louisiana typically have 110 volunteers serving 254 children.

Sally Erny, Chief Program Office for National CASA, echoed praise of CASA programs in Louisiana.

"We have found the work of the local CASA programs in Louisiana, as well as the Louisiana CASA Association, to be impressive. With the support of Louisiana CASA and the Louisiana Supreme court, local programs have grown and thrived in recent years. In total, CASA programs have over 1,500 active volunteers serving 4,000 abused and neglected children. This is a significant impact in a state where strong, high quality advocacy for children is critically needed.

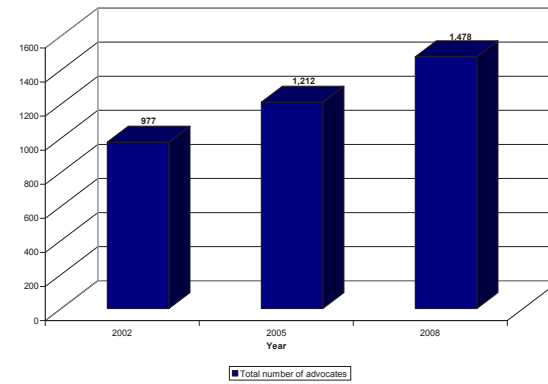
We are proud to be a partner with the Louisiana CASA Association and local CASA programs around the state and pledge our continued support to their efforts."

There has been a steady growth of over 20% increase of CASA Volunteers since 2002.

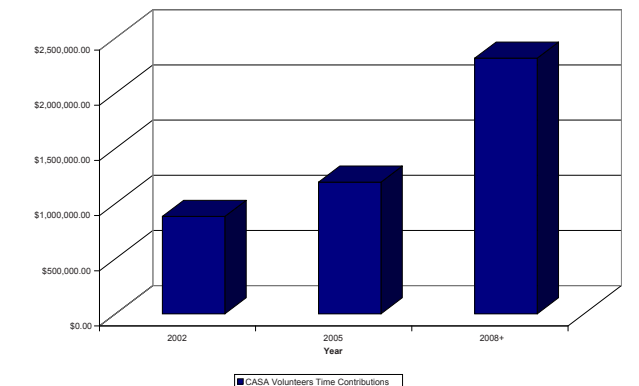
2008 Was Quite a Busy Year for Training. Below are the highlights:

- Hosted 10 court improvement program core trainings all across the state with over 500 attendees.
- Provided volunteer training for 5 local programs
- Brought in National CASA staff member Terene Bennet to train local program staff on diversity issues with over 30 attendees
- Organized a statewide OCS and CASA cross training attended by nearly 100 CASA and OCS staff, including regional OCS staff.
- Developed a day long professionalism program for new local program staff and VISTA volunteers
- In June over 40 local program staff and LaCASA staff attended the National CASA conference in Washington, DC.
- Organized a teleconference with National CASA staff member Shelley Morgan for the 12 local programs going through self assessment
- Had a delegation of 8 local program CASA staff to the National CASA "Train the Trainer" weeklong training in Atlanta
- Had over 200 attendees at our annual Together We Can conference
- Sent state and local staff to the LANO conference
