## ▶ Capital Area CASA Association

In 2009, 11 Capital Area CASA staff members supported CASA's mission. Four pre-service training sessions prepared 109 new volunteers for their roles. 193 advocates volunteered. 278 children had a voice in court. 7,444 service hours were reported by CASA volunteers. 129 children reached safe and permanent homes.

## ▶ Youth Service Bureau – CASA

Last year in St. Tammany and Washington Parishes, 154 Youth Service Bureau CASA volunteers provided top quality advocacy and served as a powerful voice in court for 387 abused and neglected children. YSB CASA staff worked throughout the year to increase awareness of child abuse and recruit CASA volunteers, reaching over 1,400 citizens through live presentations throughout the community.

## ► **CASA of St. Landry, Inc.**

CASA of St. Landry, Inc. officially became an independent program in July of 2009 and during the year 21 volunteers advocated on behalf of 40 children appointed to the program.

## **2009 Was Quite a Busy Year for Training.**

### **Below are the highlights:**

- Hosted 10 court improvement program trainings all across the state with over 500 attendees.
- In January, National CASA staff members Terene Bennett, Veronica Montaña-Pilch and Tracy Evans presented on diversity issues at our multidisciplinary “Together We Can” conference.
- In March, National CASA staff member Brien Aguilar trained over 30 local program staff on how to better use the National CASA-developed database to track information on volunteers and children and generate statistical reports.
- In April, over 40 local program staff and LaCASA staff attended the National CASA conference in Washington, DC. Staff from Louisiana CASA and from several local programs were invited presenters for the conference.
- In September, National CASA staff members Terene Bennett and Tracy Evans led a week-long training for 30 local program staff on facilitating training for new volunteers.
- Had over 200 attendees at our annual “Together We Can” conference.
- Sent state and local staff to the LANO (Louisiana Association of Nonprofit Organizations) conference.
- Louisiana CASA staff member Jacqueline Wilson was the featured speaker for one of National CASA’s semi-monthly podcasts.
- Revonda Kirby came on board in November 2009 as Training Coordinator.

## CASA Partners with AmeriCorps VISTA Program

In 2009, Louisiana CASA's AmeriCorps VISTA members served with local programs. Their activities included speaking engagements, developing recruitment materials, and developing other resources to expand the efforts of local CASA programs. VISTA members serve all over Louisiana including Hammond, New Iberia, Plaquemine, Denham Springs, and New Orleans.

## ► CASA of Lafourche

CASA of Lafourche became an independent non-profit organization in October 2009. In the month of November, they had their biggest training ever, swearing in 17 new volunteers. To date, 59 volunteers have been trained and 64 children served.

## ► CASA Jefferson

In 2009, 207 advocates were assigned to 363 children in Jefferson Parish. Volunteers conducting CASA advocacy logged 22,011 activity hours in 2009. CASA Jefferson, along with Office of Community Services, Greater New Orleans Region/Jefferson District, was recognized by the National CASA Association for innovative child welfare practices and collaboration.

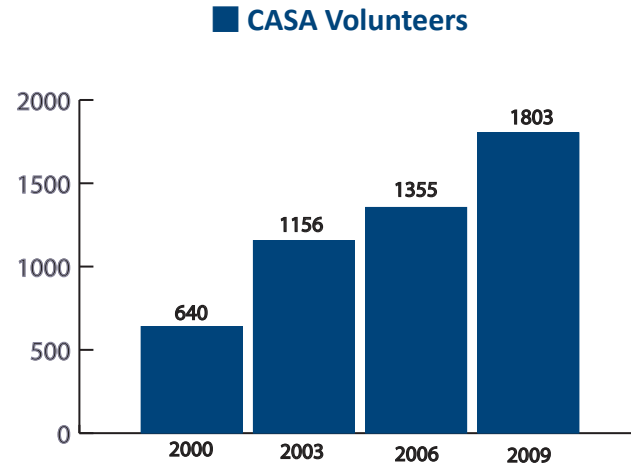
## ► CASA of NELA (Northeast Louisiana)

CASA of Northeast Louisiana serves 11 parishes and has 4 satellite offices. 224 dedicated advocates contributed 22,823 hours to advocacy and traveled 73,101 miles to serve 482 children. CASA of Northeast Louisiana presented at state and national levels on Volunteer Management and Retention. CASA of Northeast Louisiana also presented at the Foster Parent Association Meeting.

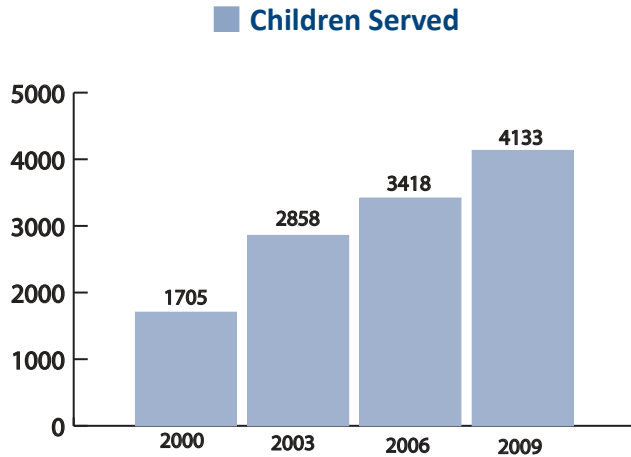
## ► In 2009, the hourly contributions of CASA volunteers



The number of CASA volunteers serving children has nearly tripled since 2000. There were 325 more volunteers active in 2009 than 2008, an increase of over 20% (1,478 volunteers in 2008 compared to 1,803 volunteers in 2009).

The number of children served by CASA volunteers has more than doubled since 2000. In 2009, volunteers served a total of 414 more children than in 2008, an increase of over 10% (3,719 children served in 2008 compared to 4,133 children served in 2009).

## ► Child Advocacy Services, Inc.

Child Advocacy Services CASA served more children in 2009 and had its biggest year ever! Covering over 10 parishes and serving five Judicial Districts, CASA served 452 children with 185 volunteers. Of that number, 141 were placed in safe and permanent homes.

## ► CASA New Orleans

CASA New Orleans served 100% of the children assigned to them in 2009. In 2009 a total of seventy-five (75) new volunteers were trained and a total of 145 volunteers served 201 children. Also in 2009, CASA New Orleans significantly increased the number of African-American volunteers and male volunteers to better reflect the demographics of the children they serve.

While 45% of the population of East Baton Rouge Parish is African American, 90% of the children served by CASA are African American. Capital Area CASA came to understand the importance of

the CASA program – staff, board of directors and advocates – becoming more culturally competent in all areas.

▶ **CASA of West CENLA**

In 2009, CASA of West CENLA had 35 active volunteers who served 136 children. For the first time, one of their advocates was asked to testify in an abuse case in the Army's court-martial of a soldier. The agency was chosen as the Chamber of Commerce Non-Profit of the Year in 2008 in



Beauregard Parish and 2009 in Vernon Parish.

▶ **CASA of Plaquemines**

Louisiana welcomed its newest program, CASA of Plaquemines Parish, when it received provisional approval in December 2009. Starting out with only 2 advocates, Director Peggy Morris plans to grow the program as quickly as possible to provide advocates for all of Plaquemines Parish's children in care.

## ► CASA of Terrebonne, Inc.

In 2009, CASA of Terrebonne held two successful fundraisers, CASA for Kidz Spring Fest “A World of Fun” and the CASA Draw Down. Both events brought in needed funds to help the program. Three pre-service training classes were held, swearing in 18 new volunteers. 48 active volunteers served 119 children. Of these children, CASA volunteers helped 41 children reach safe and permanent homes in Terrebonne Parish.

## ► Rapides CASA

Rapides CASA spent the year of 2009 gearing up on community awareness and volunteer recruitment. Through multiple community-sponsored events and speaking engagements they were able to increase their volunteer recruitment by 22%. They doubled the number of minorities who volunteer for Rapides CASA and saw a dramatic increase in number of CASA Volunteers under the age of 40. Through advocacy and volunteer retention efforts, they provided services to over 300 children utilizing 91 volunteers.

## ► CASA of the 16th JDC, Inc.

On March 16, 2009, CASA of the 16th JDC became an independent non-profit CASA program. CASA of the 16th JDC, Inc. also increased its volunteer base from only 10 advocates to 45 advocates during 2009. These 45 volunteer advocates spent 3,834 hours in service to a total of 133 children and helped 33 of those children find safe, permanent homes.

## ► CASA of SoLA

In 2009, CASA of SoLA was proud to double their volunteer base from 15 to more than 30 volunteers. Over 100 children were served and 37 children were placed in permanent homes. CASA of SoLA also received 501c3 status and moved to a bigger and better office space to accommodate their growing program.

## ► **CASA, A Program of Family and Youth**

CASA, a program of Family & Youth, reached a significant milestone in serving over 200 abused and neglected children annually for the first time. Volunteers advocated on behalf of 233 children in 2009, up from 180 children served in 2008.

## ► **Volunteers for Youth Justice – CASA**
